Applicants must use natural gas for all equipment installed, and a furnace, with a sealed combustion unit, must be the primary heat source for the home's living space. Dual fuel systems are not eligible. All products must comply with applicable federal, state, and local laws and regulations, including building codes, and manufacturer's specifications. All equipment must be new. Old equipment must be removed or permanently disconnected. A completed signed application and itemized invoices for materials and labor must be submitted to Fountaintown Gas Co., Inc. within sixty (60) days of project completion. The invoice must indicate the date of purchase/installation, make, model, size, type, and total project cost. Please allow up to eight (8) weeks to receive rebate. Incomplete applications, including those without supporting documentation, will not be processed. Fountaintown Gas Co., Inc. reserves the right to verify sales receipts and/or installations of products before issuing rebates. A random inspection may be conducted to verify installations. Rebates may be subject to federal and/or state income tax reporting. Applicant is responsible for determining tax liability. Fountaintown Gas Co., Inc. reserves the right to deny or limit any rebate request.
